Each month a lucky winner will be drawn and win \$500 cash (excluding the December draw winning the Suzuki).

2. PRIZE

- 2.1 One (1) new model Suzuki Swift prize (Including ORC), as provided by the Promoter, will be awarded per region of Tauranga, Rotorua, Whakatane and Gisborne.
